2. **We discourage Reserves.** It is agreed that all goods shall be sold to the highest bidder without a reserve unless noted. If reserved, Seller shall pay a \$20 Reserve Fee to be refunded only if the reserved item sells.
3. Auctioneer shall withhold from the sale proceeds a **commission of 15%** of the winning bid price.
4. The Buyer shall also pay Auctioneer 10% of the sale price if the purchase is made with cash or check, or 13.5% if the purchase is made with a credit card. This is called a Buyer's Premium and it is in addition to the commission paid by the Seller.
5. Seller retains all risk of loss for all property left at the auction premises. AAA Auction specifically advises Sellers not to leave their crafts unattended. Also, AAA Auction and Midwest Mountaineering do not guarantee bad checks or fraudulent purchases.

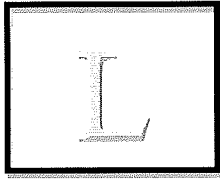

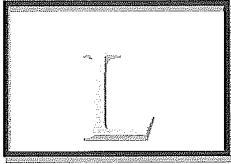

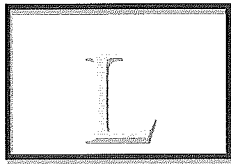
